The optimized blend of random and oligo(dT) primers provides robust, consistent and unbiased first-strand synthesis over a broad range of RNA template concentrations. qScript reverse transcriptase is a mixture of an engineered MMLV RT and a ribonuclease inhibitor protein. The simplified reaction procedure is ideally suited for high throughput expression studies using real-time quantitative RT-PCR. The resulting cDNA product is directly compatible with current real-time PCR methods or conventional endpoint RT-PCR of targets ≤1 kb in length.

**RNase:** RNase activity must be below the detectable limits of 1 pg RNase A equivalent as assayed using a fluorogenic substrate following a 1 hour incubation at 37°C with each kit component at 1X concentration.
